Association v. City of Berkeley) will likely delay an informational item on green building
reach codes being presented to the City Council. She also noted that the City's Chief
Building Official has resigned, and that the position will be filled by a consultant until a
replacement is found.

SUSTAINABILITY COMMISSION FY 2023-24 WORK PLAN

BACKGROUND

From Commissions, Committees, and Board Manual:

"All programs and major projects of Council Commissions, Committees, and Boards must be approved by the City Council. Each year, Council Commissions, Committees, and Boards shall develop a work plan which contains their goals and objectives for the coming fiscal year. This work plan shall be transmitted to the City Council."



COMMISSION PURPOSE

The Sustainability Commission serves as an advisory body to the City Council on matters related to reducing greenhouse gas emissions, sea level rise, and other environmental issues including but not limited to, wildfire, tree preservation/replacement, resiliency, and adaptation to climate change.



COMMISSION DUTIES

- a) Contribute to the development of an updated Climate Change Action Plan for Council approval.
- b) Monitor and report to the Council on the implementation of the Council-adopted Climate Change Action Plan.
- c) Recommend priority sustainability, sea level rise, environmental protection and other environmental issues, and climate-related policies and programs for City Operations and the community at large to the City Council for consideration.

COMMISSION DUTIES

- d) Review annual Sustainability Program workplan and suggest modifications, as needed.
- e) Monitor, evaluate, and communicate progress toward achieving sustainability and climate-related goals.
- f) Identify funding opportunities to support implementation of sustainability, sea level rise, environmental protection and other environmental issues, tree preservation/replacement and climate-related priorities, including leveraging regional funding to achieve shared objectives.

COMMISSION DUTIES

- g) Advocate for policies and programs that protect the environment, reduce greenhouse gas emissions, and support climate adaptation as part of Council's annual planning, goal setting, and budgeting processes.
- h) Facilitate regular community engagement on sustainability and climaterelated initiatives.
- i) Mobilize community action to reduce greenhouse gas emissions by supporting education and outreach efforts.
- j) Identify priority sustainability actions to reduce greenhouse gas emissions in City operations and the Novato community to implement actions that address the challenge of our changing climate.

PROPOSED WORKPLAN ITEMS

- I. Contribute to the development of the Climate Action Plan.
- 2. Recommend priority sustainability and climate action policies and programs to Council for consideration as part of annual planning, goal setting, and budgeting processes.
- 3. Identify funding opportunities to support implementation of priority sustainability and climate action policies and programs.
- 4. Support education and engagement initiatives to mobilize community action to reduce greenhouse gas emissions.
- 5. Review Sustainability Program FY 2023-24 Workplan and 2021 GHG Emissions Inventory.
