F.3. Receive a Presentation on AB481 (Military Equipment Policy)

Captain Sasha D'Amico presented on Assembly Bill 481 (AB481), Military Equipment Funding, Acquisition and Use Policy. Captain D'Amico began by providing background on AB481. She gave information on patrol rifles and less lethal options, Novato's armored rescue vehicle, drones and robots, night vision goggles, and specialized firearms and ammunition. Captain D'Amico relayed information on all 2022 deployments, which included use of the armored rescue van and the Crisis Response Unit. She also communicated that the drone was deployed on four different instances in 2022. There were no complaints in 2022 with regard to use or deployment of Novato's military equipment.

Board Members Palmini, Ritter, Glasscock, and Chair Drouillard provided Captain D'Amico with questions and comments. Captain D'Amico responded to all questions.

F.4. Receive and Discuss a Presentation on the Police Department Complaint Process

Captain Sasha D'Amico presented on the Novato Police Department community complaint process. Captain D'Amico detailed what a complaint is and how they are received by the Department. The investigation of the complaint is preliminarily handled by the Supervisor, then forwarded to the Supervisor's Lieutenant, and the recommendation will be shared with the Captain and Chief. The Chief handles the course of action.

As part of the investigative process, there is an interview with the community member complainant, as well as any employee witnesses

available. Captain D'Amico provided information on the Public Safety Officer Bill of Rights.

Board Members Palmini, Glasscock, Medigovich, Ritter, Vice Chair Dow, and Chair Drouillard provided Captain D'Amico with questions and comments. Captain D'Amico, along with Chief Johnson, responded to all questions.

F.6. Review of Department Activity and All Citizen Complaints Filed Since Last Meeting

Chief Johnson relayed that there were 3 citizen complaints since the last meeting in February. The complaints were based in bias, discourtesy, neglect of duty, discrimination, unlawful arrest, unreasonable use of force, etc. Complaints 1 and 2 were exonerated. Complaint 3 contained dispositions of exonerated or unfounded, except for one complaint against an officer of verbal discourtesy was sustained.

Chief Johnson also noted that NPD had participated in several community events such as the San Ramon Girl Scout Tour, NPD Awards Ceremony, Read Across America Day, Coffee with NPD, National Public Safety Telecommunicators Week, Special Needs Safety Event, and Western Oaks HOA Safety Event. She also reported on the start of the Spanish Language Community Academy.

Board Members Palmini and Ritter provided Chief Johnson with questions and comments. Chief Johnson responded to all questions.

CALIFORNIA SENATE BILL 2 PARB PRESENTATION AUGUST 2023

NOVATO POLICE DEPARTMENT
CAPTAIN JIM CORREA

SB2 LEGISLATION:

Legislation took effect January 1, 2023. Includes the follow categories:

- 1. Hiring and Selection
- 2. Certificates and Proofs of Eligibility
- 3. Decertification and Reporting Obligations*Applies only to sworn personnel

What is SB2?

- Establishes a requirement that peace officers be certified by the California Commission on Peace Officer Standards and Training.
- Requires additional background checks to ensure candidates have not been decertified at another department, including out of state. Includes additional screening for bias.
- Provides a mechanism to revoke or suspend that certification due to serious misconduct.
- Department must report complaints or allegations of serious misconduct to CA POST within 10 days of receiving the information. Retroactive reporting requirements back to January 2020.
- Must complete internal affairs investigations, even when the officer separates employment or resigns.

SERIOUS MISCONDUCT DEFINED:

- Dishonesty relating to reporting, investigation, prosecution of a crime or misconduct
- Abuse of power, including intimidating witnesses, false confessions and arrests
- Physical abuse, including excessive or unreasonable use of force
- Sexual Assault, pursuant to PC 832.7

- Demonstrating bias, in violation of law, policy, or inconsistent with peace officer duties
- Acts that violate the law and are sufficiently egregious or repeated
- Participation in a law enforcement gang
- Failure to cooperate with an investigation into potential police misconduct
- Failure to intercede in use of force

Departments must report complaints and allegation, even if no factual basis or evidence.

SB2 REPORTING TO DATE:

- ▶ In compliance with SB2, NPD made 12 notifications to CA POST:
 - Reviewed 36 cases retroactive to January 1, 2020
 - Most notifications are for retroactive cases and involve bias or false arrest allegations.
 - ► ALL cases were investigated and determined to be unfounded, exonerated, or not sustained.
