# F.3. Fiscal Sustainability Plan Update

In line with a recent objective outlined in the City Council's Strategic Plan, staff requested input from Commissioners on the revision and modernization of the Fiscal Sustainability Plan established in 2013. A dedicated website is under development to present the City's financial data, including historical financial records. Additionally, an interactive fiscal model is also in progress.

Some suggestions made by Commissioners:

- Include a FAQ section: To address common questions that people may have about the City's finances. It would also help to ensure that the website is as user-friendly as possible.
- Use of visuals and graphs: Visuals and graphs can help to make complex information easier to understand.
- Summarize the City's financial state from 2014 to current: Provide an overview of the City's financial situation. This can include information on the City's revenue, expenses, and debt.
- Show comparative growth with other like communities: Ability to see how the City is doing compared to other cities of similar size. This information could be presented in a chart or graph.
- Use of a dashboard: A dashboard would provide a quick overview of the City's most important financial indicators.
- Address development and economic development: Showing the City's plans for the future. Include information on the City's plans for any new development and economic growth.
- Address possible oppositional arguments ahead of time: A proactive way to address any concerns that people may have about the City's finances. It would be helpful to anticipate common objections and provide clear and concise responses.

# F.4. Finance Department Updates

Finance Director Carvahlo-DeGraff gave an update on the Finance Departments activities:

- FY 2020/21 Audit is completed and posted on the City's website. It will be presented to City Council at the October 24th Council meeting.
- FY 2021/22 Audit preparation is in progress. The field work will begin late February 2024.
- In response to a recent change in accounting standards, staff has implemented new lease accounting procedures with the assistance of a new software system that effectively manages those leases.
- FY 2022/23 is closed, and audit preparation is being done in parallel with FY21/22.
- Consultants have been assisting with bank reconciliations, reviewing investments, and helping to catch up on A/P reconciliations.
- FY 2023/24 Budget document is almost complete and will be posted to the City's website next week. A link will be sent to Commissioners when ready.
- The December Finance Advisory Commission meeting will be cancelled.
- There will be a survey sent out soon to set a date for the joint Finance Advisory Commission and the Economic Development Advisory Commission meeting. This meeting will be held in late January or early February.
