Anyone who challenges any hearing matter in court may be limited to only those issues raised at the public hearing described therein, or in written correspondence delivered to the Zoning Administrator at, or prior to, the public hearing.

Also, when non-confidential written materials are distributed to the Zoning Administrator or City staff during a public meeting, copies shall be made available to members of the public following that meeting.
