 one of two topic-focused tables to review a set of draft adaptation and sequestrationrelated actions for potential inclusion in the updated CAP.
- 18 community members and four Commissioners reviewed the proposed actions and discussed whether to keep the action as proposed, or to modify. There was also an opportunity to propose new actions.
- Table one focused on the *Urban Forest, Healthy Soils, and Trees on Public Land;* and table two focused on *Sea Level Rise and Climate-Driven Events.*
- The CAP consultant and staff will transcribe feedback provided at the workshop for review by the Commission at a future meeting.
- E.2 Discuss and consider recommending that the City Council consider adopting the County of Marin's model reach code related to electric vehicle infrastructure.



The Climate is Warming - And Will Continue to Do So


GLOBAL AVERAGE SURFACE TEMPERATURE

Climate Change Impacts in California

- More intense and frequent heat waves/drought
- More severe and frequent wildfires
- More severe storms and extreme weather events
- Greater river flows
- Shrinking snowpack and less overall precipitation
- Accelerating sea level rise
- Ocean acidification, hypoxia, and warming



Climate Change Impacts in Marin


- By end of century, models predict a 35% increase in burned areas in Marin
- 4-5" increase in rainfall expected in Marin by mid-century
- As much as 9" increase by end of century in high emissions scenario
- "Likely" sea level rise of 10" by 2040; 2.4' (low-emissions scenario) to 3.4' (high-emissions scenario) by end of century


