E.1. Receive an update from the Ad Hoc Committee on the Diversity Day Event

Commissioner Osotio provided an update on the Diversity Day event "Celebrating Youth Voices". She announced that three speakers have been confirmed for the event, with two being referrals from the Multicultural Center of Marin and one being a senior from San Marin High School. The event will feature a speaker panel format, giving the speakers a broad framework of topics for discussion. Commissioner Luk was selected to moderate the Celebrating Youth Voices panel.

F. **GENERAL BUSINESS**

F.1. Receive a presentation about the Museum of the American Indian, from JuanCarlos Arauz, Ph.D., MAI Board Member

Barbara Clifton Zarate, from the Board of Directors of the Museum of the American Indian, presented the history and mission of the museum. She shared that the museum was established in 1960 after high school students and an archaeologist discovered ceremonial artifacts and human remains, leading to Miwok Park becoming the museum's home. The museum is now transitioning into a multicultural center.

She stated that the museum's mission is to create visibility for Native Americans and Indigenous Peoples, with a commitment to cultural sensitivity, respect, and inclusion. The museum honors the diversity and lived experiences of the Coast Miwok, Native Americans, and Indigenous Peoples of North America, both past and present.

Two upcoming special events were highlighted:

- 1. Annual Trade Feast on Saturday, September 15, 2024, featuring Native song, dance, food, and culture.
- 2. Potential film series focused on indigenous topics, in partnership with the City of Novato, to be shown at Miwok Park.

She noted the historic significance of the museum's opening on April 27, as it marks the first land acquisition by a Coast Miwok tribal council since their forced relocation from Marin County.

H.2. Staff Liaison Reports

Community Services Division Manager Drew Bendickson informed the commission of recent cultural events celebrated by the City of Novato on social media, including Ramadan and Holi.

Community Services Division Manager Bendickson announced the grand opening of Pioneer Park, Marin County's first inclusive playground, scheduled for April 13th.

He also shared details about the 3rd Annual Novato Spectrum Safety Event at Pocket Park on April 20th. This event is specifically designed for the adaptive needs community to meet and interact with Novato's first responders and is not intended for families without adaptive needs requirements. Families who would directly benefit from the event are requested to RSVP by direct messaging NovatoFun on social media or emailing novatofun@novato.org.

Community Services Division Manager Bendickson reminded the commission about the Community Budget Workshop on Thursday, March 28th at 6pm, available both in-person at Novato City Hall and virtually via Zoom. The workshop provides an opportunity to learn about the City's budget, ask questions, and share feedback to help develop the budget and fiscal plan for the next year. Those unable to attend in person can visit novato.org/budget for details on virtual participation or to watch the meeting recording.

Lastly, Community Services Division Manager Bendickson noted that the spring recruitment for Committees, Commissions, and Boards (CCBs) was closing on Sunday, March 31st. He encouraged those interested in serving their community to apply for a CCB position, with applications accepted year-round and recruitments held twice per year.
