ENGINEER'S REPORT FOR FISCAL YEAR 2024-25

The preparation of this Annual Engineer's Report ("Report") is in conformance with the obligation of the City Council for the San Marin Landscape Assessment District of the City of Novato to provide landscaping services upon each lot or parcel of land in the district in proportion to the estimated benefit to be received by each such lot or parcel of land for Fiscal Year 2024-25.

Pursuant to the Landscaping and Lighting Act of 1972 (Part 2 Division 15 of the Streets and Highways Code of the State of California, commencing with Section 22500) ("Act"), Article XIIID, Section 4(a) of the State of California Constitution, and in accordance with the City of Novato's City Council, this Report has been ordered for:

(Hereinafter referred to as the "District"),

I, Alison Bouley, authorized representative of the District, the duly appointed Assessment Engineer submit the following Report which consists of the following four (4) parts and Appendices:

PART I – OVERVIEW

Overview

GENERAL DESCRIPTION OF THE DISTRICT

The San Marin area was developed in the 1960s and the medians along San Marin and San Andreas Drives were originally landscaped with lawns and some non-native plants. The 1975-1977 drought temporarily curtailed watering and much of the landscaping declined or died. Funds for replanting were difficult to obtain as a result of Proposition 13, which was enacted by the California electorate in 1978.

A plan for the re-landscaping evolved wherein the City funded the \$180,000 project and the San Marin Homeowners agreed to a special assessment district to fund the ongoing maintenance and for the repairs of landscaping within the District.

COMPLIANCE WITH THE CALIFORNIA CONSTITUTION

Assessments are levied annually pursuant to the Landscape and Lighting Act of 1972, Part 2 of Division 15 of the California Streets and Highways Code ("1972 Act"). All assessments described in this Report and approved by the City Council are prepared in accordance with the 1972 Act and are in compliance with the provisions of the California Constitution Article XIIID ("Article XIIID"), which was enacted with the passage of Proposition 218 ("Prop 218") in November 1996.

In accordance with the requirements of Prop 218, on July 8, 1997, the property owners approved a formula for increasing assessments in succeeding years that allows the maintenance cost to increase according to the San Francisco/Oakland/Hayward Consumer Price Index for all Urban Consumers (CPI-U).

Any future increase in the assessment rate, beyond the annual CPI-U adjustment, or substantial changes in the services provided that would cause an assessment increase would require that the District be brought into compliance with all of the requirements of Article XIIID and would require the approval of the property owners per Prop 218.

PART II – PLANS AND SPECIFICATIONS

Plans and Specifications

LEVEL OF MAINTENANCE SERVICES PROVIDED

The costs for providing for the landscape maintenance program are divided into the following categories:

- 1) Contract Services for Routine Landscape Maintenance, including SMIA management fee
- 2) Irrigation Maintenance and Plant Replacements
- 3) Allocated Salaries for District Administration
- 4) Water & Electricity
- 5) Administrative Services
- 6) A County of Marin Fee to collect the assessments

As generally defined in the 1972 Act, maintenance and servicing of the improvements may include one or any combination of the following:

- 1) The installation or planting of landscaping.
- 2) The installation or construction of statuary, fountains, and other ornamental structures and facilities.
- 3) The installation or construction of public lighting facilities, including, but not limited to streetlights and traffic signals.
- 4) The installation or construction of any facilities which are appurtenant to any of the foregoing or which are necessary or convenient for the maintenance or servicing thereof; including but not limited to, grading, removal of debris, the installation or construction of curbs, gutters, walls, sidewalks, or paving, or water, irrigation, drainage, or electrical facilities.
- 5) The installation of park or recreational improvements including, but not limited to the following:
 - a) Land preparation, such as grading, leveling, cutting and filling, sod, landscaping, irrigation systems, sidewalks, and drainage; and,
 - b) Lights, playground equipment, play courts and public restrooms.
- 6) The maintenance or servicing, or both, of any of the foregoing including the furnishing of services and materials for the ordinary and usual maintenance, operation, and servicing of any improvement, including, but not limited to:
 - a) Repair, removal, or replacement of all or any part of any improvements;
 - b) Grading, clearing, removal of debris, the installation, repair or construction of curbs, gutters, walls, sidewalks, or paving, or water, irrigation, drainage, or electrical facilities;
 - c) Providing for the life, growth, health, and beauty of landscaping, including cultivation, irrigation, trimming, spraying, fertilizing, or treating for disease or injury;
 - d) The removal of trimmings, rubbish, debris, and other solid waste;
 - e) The cleaning, sandblasting, and painting of walls and other improvements to remove or cover graffiti;



- f) Electric current or energy, gas, or other agent for the lighting or operation of any other improvements; and,
- g) Water for the irrigation of any landscaping, the operation of any fountains, or the maintenance of any other improvements.
- 7) The acquisition of land for park, recreational or open-space purposes, or the acquisition of any existing improvement otherwise authorized by the 1972 Act.
- 8) Incidental expenses associated with the improvements including, but not limited to:
 - a) The cost of preparation of the report, including plans, specifications, estimates, diagram, and assessment;
 - b) The costs of printing, advertising, and the publishing, posting and mailing of notices;
 - c) Compensation payable to the County for collection of assessments;
 - d) Compensation of any engineer or attorney employed to render services;
 - e) Any other expenses incidental to the construction, installation, or maintenance and servicing of the improvements; and,
 - f) Costs associated with any assessment balloting held for the approval of a new or increased assessment.

Pursuant to the 1972 Act:

"Maintain" or "maintenance" means the furnishing of services and materials for the ordinary and usual maintenance, operation, and servicing of any improvement, including repair, removal, or replacement of all or any part of any improvement.

"Service" or "servicing" means the furnishing of electric current or energy, gas, or other illuminating agent for any public lighting facilities or for the lighting or operation of any other improvements.

The landscaping improvements are contained within public median islands along San Marin and San Andreas Drive, and other miscellaneous areas in the San Marin area. The specific areas being maintained by this District are also shown on the diagrams in Appendix B of this Report.

Note: The total number of Assessment Units (1,584.81), multiplied by the Assessment Per Unit (\$48.13) equals \$76,276.98, which differs from the actual Proposed Assessment amount of \$776,250.28. This is due to rounding the actual assessment down to an even penny, which is required by the County for tax roll submittal.

In June 1983, the City, by contract with the San Marin Improvement Association (SMIA), delegated to the SMIA, the management of the maintenance services for the District's improvements. The City retained the administrative and legal responsibilities. The agreement self-renews annually so long as the SMIA satisfactorily fulfills its duties as prescribed in the contract with the City of Novato.

All improvements within the District are maintained and serviced on a regular basis. Based upon the available revenues generated by the assessment, SMIA representatives determine the frequency and specific maintenance operations which can be provided in a given year. The proposed expenditures for this fiscal year include the routine maintenance of the existing landscaping on San Marin and San Andreas Drive, additional replacement of landscaping that has reached the end of its useful life, and extraordinary landscape/tree trimming. SMIA is proposing \$20,000 in improvements for FY 2024/25. Those improvements include infrastructure improvements, system repairs, bark placement, tree pruning, or new plantingsas well as unplanned repairs for the median strips.

The responsibilities of the City and SMIA pursuant to the agreement are summarized below:

City	SMIA

The proposed budget for Fiscal Year 2024-25 is shown on the previous page. This includes an estimate of the costs of utilities, operations, services, administration and maintenance associated with the improvements within the district, including all labor, personnel, equipment, materials and administrative expenses. The budget summary also shows the estimated fund balance and the projected fund reserves that will be available and may be required based upon the estimated expenditures and assessment revenue.

PART IV – METHOD OF APPORTIONMENT

Method of Apportionment

GENERAL PROVISIONS

The 1972 Act permits the establishment of assessment districts by agencies for the purpose of providing certain public improvements which include the construction, maintenance and servicing of public lights, landscaping and appurtenant facilities. The 1972 Act further requires that the cost of these improvements be levied according to benefit rather than assessed value:

"The net amount to be assessed upon lands within an assessment district may be apportioned by any formula or method which fairly distributes the net amount among all assessable lots or parcels in proportion to the estimated benefits to be received by each such lot or parcel from the improvements."

The formula used for calculating assessments in the District therefore reflects the composition of the parcels, and the improvements and services provided, to fairly apportion the costs based on estimated benefit to each parcel. In addition, pursuant to Prop 218:

"No assessment shall be imposed on any parcel which exceeds the reasonable cost of the proportional special benefit conferred on that parcel. Only special benefits are assessable and an agency shall separate the general benefits from the special benefits."

BENEFIT ANALYSIS

Each of the improvements have been carefully reviewed by the City and the corresponding assessments have been proportionately spread to each parcel based on improvements as determined at the time the District was established, and later affirmed in a Prop 218 balloting conducted July 8, 1997.

General Benefits

The improvements within this District are a direct result of property development within the District and would otherwise not be required or necessary. Developers typically install landscape improvements to enhance the marketability of properties within the development and/or as conditions of development. In either case, the improvements are clearly installed for the benefit of the properties developed and not for the benefit of surrounding properties.

Although many landscape improvements (by virtue of location), may be visible to surrounding properties or to the public at large, any benefit to surrounding properties is incidental and cannot be considered a direct and special benefit to those properties. Therefore, it has been determined that the improvements within this District and the ongoing operation and maintenance of those improvements are clearly a direct and special benefit to properties within the District. Unless otherwise noted, these improvements provide no measurable benefit to properties outside the District or to the public at large.



Special Benefits

The method of apportionment (assessment methodology) approved at the time the District was formed is based on the premise that each of the assessed parcels within the District receives benefit from the improvements maintained and financed by annual assessments. Specifically, the assessments are for the maintenance of local landscape improvements installed as part of the original improvement. The desirability and safety of properties within the District are enhanced by the presence of well-maintained landscaping. The special benefits associated with the local landscaping improvements are specifically:

- Enhanced desirability of properties through association with the improvements.
- Improved aesthetic appeal of properties within the District providing a positive representation of the area.
- Enhanced adaptation of the urban environment within the natural environment from adequate green space and landscaping.
- Increased sense of pride in ownership of property within the District resulting from well-maintained improvements associated with the properties.

All of the preceding special benefits contribute to a specific enhancement and desirability of each of the assessed parcels within the District.

Non-Assessable Parcels

Within the boundaries of the District, there are several types of properties that are considered to receive no special benefit from the District improvements and are therefore not assessed. These parcels may include:

- 1) Publicly owned parcels that are reserved as Public Open Space or are developed as City Parks for active recreation and are maintained and serviced by the District;
- 2) Publicly owned wetland parcels;
- 3) Certain Public Utility parcels;
- 4) Privately owned open space parcels; and
- 5) Privately owned "sliver" parcels that have resulted from a lot line adjustment with an adjacent larger parcel



ASSESSMENT METHODOLOGY

The Engineer's Report for the 1997 Proposition 218 election included a very detailed evaluation of the method of apportionment (assessment spread) for this district and is quite lengthy in its discussion and analysis of the assessment methodology. The current method of apportionment is essentially the same as the one adopted at the creation of the district in 1983. The information from the 1983 report is incorporated herein for reference, and is filed at the Engineering Division of the Public Works Department. Assessable parcels are assigned an Equivalent Dwelling Unit (EDU) measure based upon multiple factors including land use and proximity to the improvements. The EDU total for each assessable parcel is multiplied by the assessment rate per EDU with the resulting product being the parcel's annual assessment amount for the fiscal year. A district summary of this methodology is shown below, along with the quantification of the district maximum assessment rate.




