Conduct a public hearing and consider adopting a resolution recommending the City Council:

Amend Novato Municipal Code Section 19.34.030 (Accessory Dwelling Units) to: 1) incorporate recent revisions to State law addressing accessory dwelling units ("ADU" and "ADUs"; 2) modify permitting requirements for certain types of ADUs; and, 3) modify existing and add new text to clarify various provisions applicable to ADUs;
- B. Amend Novato Municipal Code Section 19.34.032 (Junior Accessor Dwelling Units) to incorporate recent revisions to State law addressing junior accessory dwelling units ("JADU" and "JADUs"); and
- C. Find the referenced amendments to be exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15282(h) and Public Resources Code Section 21080.17
