## ITEMIZED INSTRUCTIONS FOR COMPLETING TEMPORARY SIGN ENCROACHMENT PERMIT APPLICATION

The "Applicant" is solely responsible to provide all necessary and accurate information. Clearly PRINT or TYPE all information. Do not leave any spaces blank. Write "n/a" if not applicable. Any missing or illegible information must be provided before encroachment permit can be issued. Below is more information for completing each box <u>Items</u> <u>Numbered (1 through 8)</u> on reverse side of this form.

- (1) The person completing and signing this application is the "Applicant." Provide First and Last Name of the person completing and submitting this application on behalf of the Organization (Business) hosting the Event. Provide the Name of the Organization (Business). Applicant certifies by submitting application that they are the Authorized Agent representing the Organization (Business) applying for the temporary event sign encroachment permit. Provide City of Novato Business License Number.
- (2) Provide the Address of the Applicant, or the Organization / Business, hosting the Event. Provide full street address, City and Zip. (P.O. Box will NOT be accepted.) Check one of the boxes either for Applicant or Organization / Business that represents the address information provided.
- (3) Provide Applicant's daytime telephone number, a cell phone number that will only be used for 24 hour emergency contact and an email address, if available.
- (4) Write in the total number of signs to be installed at approved City right-of-way locations. All temporary event signs must have an approved Novato Sticker attached to the front, bottom right-hand corner of each sign. The stickers will be provided at the time the encroachment permit is issued. Signs not displaying an approved sticker will be immediately removed and discarded without further notice. A replacement sticker may be purchased for a cost of \$1.00 each.
- (5) Provide the Event will Start Date and the Last Date of the Event. Add fourteen (14) calendar days after the Last Date of the event and enter the "Remove Signs By" Date. The Permittee is responsible for removing ALL temporary event signs. Failure to remove signs by date specified in the encroachment permit may result in the full or partial loss of any deposits, required reimbursement invoiced to the Permittee for the costs incurred by the City to remove signs, and possible code enforcement action and possible denial of future temporary event sign permits to the Permittee, Applicant, Organization / Business that failed to remove the signs as permitted.
- **(6)** Provide a Description of the "Event" and attach a photograph, plan or detail that shows the proposed sign including all the language, dimensions, pictures and colors. Date(s) of the Event must be shown clearly on the sign.
- (7) Write in the dimensions of the proposed temporary signs, height and width. Provide the dimensions in feet and to the nearest inch. Maximum permissible sign area is 24 square feet. Any signs placed in the City right-of-way exceeding the maximum limit will be immediately removed without further notice and subject to code enforcement action.
- (8) Applicant must be sign and date application before processing by the City. Upon Applicant signing the Application and any Permit issued as a result of an approved application, the Applicant(s) and the Permittee(s), each and all, agrees to indemnify, defend and hold harmless the City of Novato, its officers, agents, and employees any and all loss, damage, liability, cost or expense, however same may be caused, that may arise during or as part of the permit process, or during or as part of any permit issued, whether the liability, loss or damage is caused by, or arises out of, the negligence of the City, its officers, agents, or employees, or otherwise. Applicant and Owner(s) further agree to comply with all applicable City Ordinances, City standards and specifications, terms, conditions and any restrictions associated with this application and any permits issued.







X Areas within the City's Right-of-Way.








