

Measure F Oversight/ Citizens Finance Committee

Attendance and Conduct:

- a. A Committee member shall resign upon three unexcused consecutive absences.
- b. Meetings shall be conducted according to Roberts Rules of Order and subject to the Brown Act.
- c. The Committee, as public servants, shall display respect to all members of the public, staff and other Committee members.

Membership:

- a. The Committee shall be comprised of seven (7) members.
- b. Members shall reside within the City of Novato.

Term:

- a. The first term of four Committee member seats shall be three (3) years.
- b. The first term of three Committee member seats shall be two (2) years.
- c. The City Council will determine which seat each appointed member is assigned to.
